RELEASE FORM - READ CAREFULLY

1. I acknowledge reading, understanding and agree to all tournament rules and understand that all local, state, US Coast Guard and federal laws and boating/fishing regulations apply to this tournament. I also agree to follow any oral instructions or directions given by "Ding" Darling Wildlife Society or the employees, representatives of the "Ding" Darling Wildlife Society/Tournament committee.
2. Interpretation and enforcement of the Rules shall be left to the exclusive discretion of the Tournament Director or his/her designee. In the event of a rule violation, the Tournament Director may impose such sanctions, as he/she deems appropriate, including, without limitation, disqualifications, forfeiture of prizes and prohibition from participation in subsequent tournaments. Decisions of the Tournament Director are final in all matters and are not subject to appeal and are not reviewable by any court of law.

In exchange for participation in the activity of the "Ding" Darling & Doc Ford's Tarpon Tournament organized by the "Ding" Darling Wildlife Society, Inc., of 1 Wildlife Dr., Sanibel, Florida, 33957 and/or use of the property, facilities, and services of "Ding" Darling Wildlife Society, I agree for myself and (if applicable) for the members of my family, to the following:
 - o I recognize that there are certain inherent risks associated with the above-described activity and I assume full responsibility for personal injury to myself, and further release and discharge "Ding" Darling Wildlife Society Inc. for injury, loss or damage arising out of my use of or presence at the tournament headquarters in Sanibel.
